# Introduction to Comparative Welfare State Analysis: Foundations, Theories and Development

Providing social security for the population against risks such as illness, unemployment and old age is one of the core tasks of the state. For this reason, social spending accounts for a large share of the budget in most developed countries. However, there are significant differences in the type and level of spending and in the content of welfare state policy in international comparison. Why have welfare states developed so differently and what are the current challenges? In recent decades, the traditional welfare state has come under increasing pressure. From a liberal (economic) perspective, it is seen as bloated, cumbersome and creating false incentives. At the same time, social inequality is increasing in most democracies, and existing systems do not have adequate answers to new social risks.

Conflict is a persistent element of human history, and its current impact is unprecedented since World War II. By 2022, 108.4 million people had been forcefully displaced—2.5 times more than a decade ago—while civilian deaths rose by 50%. Today, six out of seven people globally experience a sense of insecurity. In response, Sustainable Development Goal 16 aims to promote peaceful societies, ensure access to justice, and build effective, accountable institutions to guarantee freedom from violence and fear for all individuals.

Over the past years, VAAs have been the subject of extensive research, as scholars seek to understand their impact on political behavior, voter decision-making, and democratic processes. In this course, we will examine the theoretical foundations of VAAs, explore variations in their design and the implications of these differences, and assess their effects on the electorate.

The increasingly integrated global economy challenges governments to address policy making (in various policy areas) taking both the national and global dimension into consideration. Looking at where the interface of international and domestic policy making lies, this course introduces students to IPE theories in general and the gro- wing research body in IPE. To do so, the course combines a general textbook with published articles in high ranking journals. The first part of the course will familiarize students with IPE in general and crucial actors in studying IPE – voters, parties and government. The second part of the course will then focus on political decision making in trade and monetary policy in the international context. The third part looks at effects of globalization on e.g. child labour, foreign aid, and government spending. Particularly, in the second and third part we will also look at empirical testing of theo- retical explanations.

The European Union (EU) stands at a crossroads, grappling with transformative challenges that will shape its future. This interactive block seminar dives into the heart of these challenges by examining internal and external dimensions of EU governance. Since the establishment of the common market, the EU has continuously reshaped member states' policies across a variety of areas. Internally, we will explore how EU governance instruments impact member states' labour markets and welfare states. Externally, we will investigate how the EU exerts influence on global trade, geo-economics, and international security, highlighting the EU's norm-setting role as a key player in shaping global governance paradigms.

How to effectively study migration and human mobility with qualitative methods? What are the challenges and opportunities that these methods bring? This course will offer students a practical take on qualitative methods of data collection, applicable in migration studies: interviews, ethnography, focus groups, visual methods, mapping, discourse analysis and process tracing. It will be useful for political science students, who already have a basic understanding of qualitative methods, and provide a guidance on how to operationalise them further. Each session of the course will delve in detail into one method and analyse how it was applied in practice by reading published academic articles. The students will learn what type of data could be obtained from each method, and what are their respective strengths and weaknesses. Through such critical reflection on qualitative methods, the students will also discuss modern socio-political issues related to human mobility to Europe and North America, such as settlement, integration, border securitisation or trauma.

This course on the "Sociology of the Body" addresses a social category which has been overlooked in many early sociological theories although bodies are everywhere in society and "serve as the substratum for social life" (E. Bernstein). Yet, multiple approaches to theorizing and researching the body have emerged in recent decades. Wewillread studiesfrom scholars of the 20th century until today and examine the processes by which individual bodies are shaped by social structures, waysin which bodies are socially

constructed, represented and used - and, in turn, shape social life. We will understand bodies as situated within particular social and historical contexts and address a range of contemporary issues to illustrate this perspective. The body will be addressed not as a

pre - social physical objective fact, but as something interpreted through the lens of society and culture.

Death possesses both personal and social dimensions, which is why we will focus on grief and bereavement, seeking to understand the impact on those who remain and how culture shapes these experiences. The aim of this seminar is to provoke thoughtful consideration of a topic rarely addressed in public discourse and to explore the reasons behind this reticence.

People attach themselves towards abstract social entities, such as organizations or nation states. But what they feel attached to, and the intensity of their commitment can vary greatly. Why is this? As individuals and as groups, we feel solidarity with some people and indifference or even hostility towards others. How can this selectivity be explained? People enter into conflicts and struggle over a wide range of things, such as values, ideas or material goods. Many conflicts remain harmless and fade away after a short time, while others escalate. How does this happen? A sociological understanding of commitment, solidarity and conflict is crucial for explaining how social order emerges, reproduces itself and changes. Such an understanding is provided by micro-sociological theories, which see social exchange and interaction as the basic building blocks of the social world.
