Applications

Your students should follow the instructions emailed to them to complete our online application form.

We cannot process application forms for students who have not been formally nominated by their home university.

No additional documents (e.g. transcripts, evidence of language level) are required for incoming Erasmus students *with the exception of* students coming to study in the Belfast School of Art or Belfast School of Architecture, who will be required to submit a portfolio of work for assessment. Details of how to submit portfolios will be sent to nominated students.

Application deadlines:

A letter of acceptance will be emailed to all accepted students. The letter of acceptance will confirm the student's campus, Studies Adviser and Student ID.

Visas

Students who require a visa in order to study in the UK will be provided with advice and assistance.

Students studying at Ulster University for 6 months or less will be issued with a letter to allow them to apply for a Short-term study visa

Students studying at Ulster University for more than 6 months will be issued with a Confirmation of Acceptance for Studies (CAS) to allow them to apply for a Tier 4 Student visa.

Insurance

Liability insurance

Whilst on the University premises or engaged in an activity related to their course of study, students are covered under the University's Public Liability policy which has a limit of indemnity of £30million.



Insurance of personal possessions

Students staying in university residences will pay a booking fee, which includes an insurance premium to cover damage, loss or theft of a range of common personal possessions within their study bedroom. Students with high value items may need to buy top-up cover.

Details of cover and how to make a claim will be included with the Arrival Instructions sent to students by the Accommodation Office.

Students staying in non-university residences should take out a suitable insurance policy before they travel to the UK.

Travel Insurance

We recommend that all students take out travel insurance before they travel to the UK.

Health Insurance

All EU, EEA and Swiss nationals should apply for a European Health Insurance Card before they travel to the UK.

University restructure - Important information

Ulster University is undergoing a restructure, which will include the restructuring of our faculties and schools/departments. Restructuring should be complete by the start of the 2017/18 academic year.

As a result of restructuring, please note the following important information for 2017/18:

Students studying through an Erasmus+ Inter-Institutional agreement with the Ulster University Business School (ISCED 041/34)

With the exception of students who will be studying travel, tourism and leisure (ISCED 1015) or consumer studies, we will no longer be able to accept business students to study on our Coleraine campus.

If your university has an Erasmus+ Inter-Institutional agreement that was originally signed with Ulster University's Department of Business and Enterprise on our Coleraine campus, your students should decide whether they wish to study on our Jordanstown campus or our Magee campus.

Students studying through an Erasmus+ Inter-Institutional agreement with the Faculty of Arts, School of Modern Languages (ISCED 222/023)

Ulster University's School of Modern Languages closed in summer 2016 and there will be no modern languages provision at Ulster University from the end of 2018/19. As a result, there has been a reduction in the number of modules being taught in the areas



of Chinese, French, German, Spanish, Cultural studies, Language studies, Film and Translation.

Despite these changes, we will continue to welcome your students to study with us as Erasmus+ exchange students and provide them with a high quality learning environment.

ECTS credit system

Most undergraduate modules are worth 20 UK credits/10 ECTS credits.

The normal workload for a student at Ulster University is 60 UK credits/30 ECTS credits per semester.



Undergraduate students normally register for three 20 UK credit/10 ECTS credit modules per semester. Modules normally run over 12 weeks of teaching.
